## **Feedback questions**

The document presents for public consultation recommendations and guiding principles for the development of technical standards. We would like to know your views on guiding principles and on areas which should be prioritised by the technical committee.

To facilitate your feedback we have two specific questions detailed below.

### Questions

# **Question 1:** In the first instance, which area of work should be prioritised by the eHealth Standards Advisory Committee?

#### Please comment

Information and Communications Technology (ICT) is playing an ever increasing role in medicine and the advantages of eHealth are becoming increasingly apparent. Notably patient records can be stored, retrieved and updated much more efficiently, important information can be processed from patient files in relation to particular diseases allowing for important audit, research and planning. EHealth also allows for more efficient transfer of patient information between healthcare settings enhancing patient safety and quality of care, by reducing repetition and errors in diagnostics and treatments.

In the absence of funding and consensus for a national system of electronic health records, the interoperability of ICT systems between healthcare settings is necessary to reap the benefits of eHealth of development in Ireland. The interoperability of ICT systems requires that

- the data structure and minimum dataset within the systems be standardised,
- that there is convergence of taxonomy and terminology and
- messaging standards for the exchange of data between systems.

Without the early adoption of interoperability standards, considerable wastage may occur as current ICT projects require upgrading or replacement Equally, not all systems will need to be capable of interfacing with all other systems and complex "over-specification" will increase costs without benefit in (or perhaps to the detriment of) functionality.

The Irish Medical Organisation recommend that the eHealth Standards Advisory Commitee prioritise the adoption of a messaging standard to be applied to appropriate information systems. It is likely that a meaningful standard for messaging will require some regularising of the minimum dataset to be used within these systems.

### Question 2: Please provide us with any general comments you would like to make.

#### Please comment

The Guiding Principles for the development of interoperability standards must include reference to Patient Safety and Patient Confidentiality.

While the benefits of eHealth - in terms of efficiency and advancing medical practice to improve the delivery of healthcare – are unquestionable they can only be considered a benefit when patient safety can be assured. It will still be necessary to verify patient details as they pass from one health establishment to another

The use of ICT in healthcare raises important issues of privacy and confidentiality. The IMO Is calling for the urgent publication of the Health Information Bill to clarify issues of confidentiality, access and security in relation to electronic health records and secondary use of data.
